Just like everything else, eeds pricing is simple. There are no extra "modules", "publishers", or "hosting" to purchase. There are no per-user license fees to worry about. Below are the fees you'll be responsible for:

1. ADMINISTRATIVE FEE

\$3000 (billed annually).

2. RSS ATTENDEE SUBSCRIPTIONS

\$15 per attendee that requires transcripts (billed annually).

The pricing above gives you access to all of benefits eeds as seen on the grid on the next page. With regards to the attendee subscriptions, you can pay for as many or as few people as you want. Organizations with very large RSS attendance may qualify for a capped fee. The attendee subscription grants access to transcripts and unlimited attendance certificates per day. Those without a subscription will not have access to transcripts and will be limited to one single-activity certificate per day.

Many organizations choose to purchase subscriptions for their physician attendees, however, it is not a requirement. RSS attendees who do not have a subscription will be asked to purchase one (priced \$20-\$40) when they attempt to print an attendance transcript.

ENTER EVENT INFO

DISTRIBUTE CODE

Before the event, share with attendees the 6-digit secret code they'll need to sign-in.

OUTCOME STUDY
